Utah Partners for Health collaborates with multiple for-profit clinics willing to provide in-kind donations to individuals in need of health care in Magna, West Valley, and Kearns, Utah.

- Model I - In-Clinic Programs that provide access to 10 for-profit clinics at an average discount fees of 70%. Many received care for the price of a co-pay. 1,675 patients' visits were provided to uninsured and low income patients who would not have been able to have dental, eye care, physical therapy, pulmonology, cardiology, and other diagnostic services. \$201,934 in-kind donations were received from our partner providers in 2019.

Form 990, Part III, Line 4a - First Accomplishment

- We served 7,480 patients and had a total of 16,736 primary care visits.

- Patient encounters increased by 5.3%.

- We opened a new clinic - UPFH Family Clinic in West Jordan to meet demand, and added providers to our Behavioral Health and Dental Teams.

- Model II - The UPFH Mobile Medical Clinic went to 41 sites in Salt Lake and Tooele County. Mobile Clinics break down barriers such as transportation, language and lack of understanding of our health care system. This clinic provides free care for uninsured patients with incomes less than 200% FPL. A total of 1,300 medical visits for acute, chronic, mental health, and preventive care were provided in 2019.

- Model III - Mobile Eye Care Clinics visit area schools with the poorest children. This program works with school nurses and the United Way to improve educational outcomes for students with vision impairment. A total of 1,843 patients had eye exams and 1,752 free or low cost glasses were provided.

- Model IV - Mid-Valley Health Clinic is a Federally Qualified Health Center offering a deeply discounted sliding fee schedule for individuals with incomes 200% or less of the Federal Poverty Level. This clinic provided 6,762 primary care visits in 2019.

- Model V - Utah Partners for Health Dental Clinic provided 3,072 low-cost visits. Patients are treated with crowns, dentures, cleaning etc. A second dentist was added in 2019 to meet demand in the community and serve the low income population.

- Model VI - Utah Partners for Health Behavioral Health Clinic provided 1,083 counseling visits including no cost visits for homeless individuals. We are excited to integrate behavioral health at our Mid-Valley clinic.

- In 2019 we achieved clinical performance measures in: Child and Adult Weight and Counseling, Tobacco Cessation, Asthma, Heart Disease measures, Depression, Hypertension, Diabetes and Dental Sealants. We improved in Cervical and Colorectal Cancer Screening but missed our internal goals.
